- 2. X and Y are partners. Their capital balances as on 1 April 2024 were ₹1,50,000 and ₹1,00,000. They draw ₹5,000 and ₹4,000 per month respectively. Interest on capital is allowed at 6% p.a. and interest on drawings is charged at 5% p.a. The firm made a profit of ₹60,000 for the year. Prepare the Profit & Loss Appropriation Account and Capital Accounts of the partners (Fluctuating method).
- 3. 3. R, S and T are partners sharing profits in the ratio 4:3:3. Their capitals are ₹2,00,000, ₹1,50,000 and ₹1,50,000 respectively. Interest on capital is 8% p.a. The profit for the year is ₹45,000. Show the distribution of profit.

- The partnership deed provided:
- Interest on capital at 10% p.a.
- • No interest on drawings
- • Salary to Sameer ₹5,000 per month
- The profit for the year ended 31 March 2025 was ₹1,00,000.

- 2. How much salary will Sameer receive in the year?

- Priya and Neha are partners in a firm. They started their business without a written partnership deed. Priya contributed ₹3,00,000 and Neha ₹2,00,000. Priya wants interest on capital at 8% p.a., while Neha objects. Priya also demands a salary for managing the firm's accounts.
- During the year, the firm earned a profit of ₹50,000.

- Karan and Aryan are partners in a firm. Their capital as on 1 April 2024 was ₹1,00,000 and ₹80,000 respectively. They share profits in the ratio 3:2.
- Aryan withdrew ₹1,000 per month, and Karan withdrew ₹2,000 per month for personal use. Interest on drawings is charged at 5% p.a., and interest on capital is 6% p.a.
- The firm made a profit of ₹40,000 during the year.
- Questions:

- 1. Calculate interest on capital for both partners.
- 2. Calculate interest on drawings assuming drawings were made at the beginning of each month.
- 3. Prepare the Profit & Loss Appropriation Account.
- 4. What is the closing capital balance of each partner under the fluctuating capital method?
- 7. Case Study 4: Drawings and Interest
- Amit and Ramesh are partners sharing profits in a 1:1 ratio. Their capitals on 1 April 2024 were ₹1,00,000 and ₹1,20,000 respectively.
- During the year, Amit withdrew ₹12,000 on 1 July 2024 and Ramesh withdrew ₹12,000 on 1 October 2024. The firm charges interest on drawings @6% p.a.
